The Wrightstown Township Board of Supervisors met on Monday, January 4, 2021 in the Meeting Room of the Wrightstown Township Municipal Building, 2203 Second Street Pike, Wrightstown, PA. On a motion by Vice Chair Magne, seconded by Treasurer Lloyd, the Board voted unanimously to have Solicitor Clemons file a Notice of Non-Participation.

#### **MANAGER'S REPORT:**

- A. Balmoral (Triumph Development Group) Escrow Release #3. Triumph Development Group, LLC requested a release of \$35,284.05 from their letter of credit. Manager Pantano reviewed the request and recommended that \$29,784.05 be released, with \$244,168.71 remaining. On a motion by Treasurer Lloyd, seconded by Vice Chair Magne, the Board voted unanimously to approve the recommended release.
- **B.** S & D Venture (Sterling Limousine) Escrow Release #7. S & D Venture requested a release of \$44,099.25 from their letter of credit. Manager Pantano reviewed the request and recommended that \$44,099.25 be released, with \$72,140.89 remaining. On a motion by Treasurer Lloyd, seconded by Vice Chair Magne, the Board voted unanimously to approve the release.
